Colleen Kehoe-Robinson, District 2 Director, called the meeting to order at 11:10am

-New CoastalCC Librarian: Norrine Burton

-New PittCC Librarian: Evan Schmoll

- James Sprunt CC's renovations are finishing and they have a "re-opening" planned

-Lenoir's Early College liaison will begin bringing students in for library tours into orientation; also, Rich's communication dynamic shifting at Lenoir - he previously reported to the Dean of Student Services and now reports to the Associate Vice President of Instruction.

-CCLINC- Rich concerned about July reports and Drew's *deleteme* timeline "through July" interfering with deaccession reports for the first month of the new fiscal year. Hoping to get Drew to purge (deletes) through June but not into July.

-Elizabeth Baker - Carteret CC won a SLNC LSTA Grant and obtained funds for expanding library resources & services.

- Colleges offering “free tuition” (James Sprunt/Beaufort/etc.) and “free funding” (Carteret) for Fall 2021 semester...

-Discussed District Photo challenge - encouraging submissions from District 2

-Discussed NCCCLA Events & Training Sessions

-Discussed travel regulations at colleges - hoping to meet in person for future meetings

-Meetings and professional development events tend to focus on librarianship issues, but perhaps should (or will) begin to address more paraprofessional issues also: circulation, customer service discussion/training...

-Discussed public patrons returning: Craven/Lenoir/Beaufort and others allowing patrons back without limitations

-Discussed protocol for removing trouble patrons (public); procedures for filing complaints to College security and administration (noting their potential differences in responding)...

-Rich and the director’s institute sought and were awarded an LSTA planning grant (Lenoir, Stanly, Gaston, Catawba) for researching a new ILS. They are intending to migrate from Sirsi Dynix (to the NC Cardinal Evergreen ILS). An implementation grant will be sought for June 2022 - Lenoir CC... They encourage other colleges to consider this also.
